Marietta Metgzer proposed a change to the proposed amendments in Appendix "D" for section 9(6) of the constitution, suggesting the inclusion of the word "of" to read as follows: "9(6) Voting Members are Financial Voting Members if their annual subscription (if any) and any other moneys payable by them to the Association are paid or the overdue amounts have been due for a period '**of'** less than eight weeks."

As the motion had already been voted on, the proposed change to the wording of section 9(6) was not considered.

Marietta apologised but advised there had not been an opportunity to raise the proposed change before the vote.

6. NOMINATION FOR ELECTION OF BOARD MEMBERS

6.1 The Chair explained constitutional requirements, specifying the Board must consist of six (6) elected board members, up to three (3) appointed, and the Immediate Past President with at least three (3) Corporate Strata Manager Personal Members and one (1) Corporate Strata Services Personal Member.

There is a change in the Past President role, as she will assume the role at the conclusion of this AGM.

Elected Board Members retiring by rotation are Damien Moran, Kyra Murphy and Jason O'Meara.

7.2 Other Business

7.2.1. Discussion on Conflict of Interest and Board Governance

Scott Bellerby enquired what was the legal advice received by the board concerning potential conflicts of interest among board members who are co-owners or colleagues of a business, specifically related to personal material gain affecting their voting. Kerrin Simmonds advised the clarification sought on conflict of interest was in relation to the voting process for office bearers, Scott disagreed stating that did not address his initial query.

Scott requested confirmation that board nominees had completed and signed register of interest forms, disclosing any relationships with other board members that may impact governance. Catherine Lezer confirmed board nominees had completed and signed the forms with disclosures made by nominees facing potential conflicts of interest.

Scott queried what would be the threshold be for conflicts of interest which could potentially affect the board's effectiveness. Warren Kiddle advised all decisions by the board must undergo due process, including the assessment of all board members for conflicting interests before any vote.

Scott proposed the following:

1. Board to seek legal advice on defining a person with material gain and their eligibility to vote in board decisions if a conflict of interest exists.

2. Within the first quarter of 2024 the board to consider a constitutional cap on the number of co-owners or colleagues from the same company who can be board members at the same time.
